

AUTHORIZATION AND RELEASE

I am the custodial parent or legal guardian of the minor child named below, which child is participating or has participated in a video and/or photograph for WJRZ-FM, radio stations owned by Beasley Media Group, Inc. (collectively referred to as "Station"), at which Station personnel took photographs or made audio and/or video recordings that may include images of the minor child named below or other audio or visual images or recordings of the minor child named below supplied by myself or other third parties, including my name and city/state ("Photo/Video/Audio"). I authorize Station to use, for whatever purposes it may choose, the Photo/Video/Audio, without additional financial or other compensation. I have all rights necessary to provide this Authorization and Release ("Release") to Station. I acknowledge and agree that the Photo/Video/Audio may be displayed, published, and/or posted on the Station website and/or on the Station's various social media pages, including, but not limited to Facebook, Instagram, Snapchat, Twitter, etc., and may be distributed to local press or trade papers for promotional purposes. If posted on Station's website(s) or social media pages, I understand that Station will make commercially reasonable efforts to ensure the internet security of the Photo/Video/Audio, but cannot guarantee that its system will be free from corruption, hackers, or other technical problems or errors.

In consideration of my child/ward being able to participate in the Event, and for other good and valuable consideration, receipt of which is hereby acknowledged, I authorize Station to post the Photo/Video/Audio on its website and to use the Photo/Video for related promotional activities undertaken by Station. I represent that I am at least 18 years old and know of no reason I may not grant the rights granted in this Authorization and Release. Neither I, nor the minor child named below, is represented by a talent agent or other representative. Under no circumstances will Station be held liable or responsible for the authorized or unauthorized display, publication or duplication of the Photo/Video/Audio. I acknowledge that Station is and shall be the sole and exclusive owner of such postings or recordings of the Photo/Video/Audio and shall have the right to exploit such postings or recordings, and portions thereof, in any manner and any media whatsoever. I consent to the use, editing, reproduction, exhibit or display of such postings or recordings for advertising and publicity purposes relating to the uses by Station or its sponsors, or for any other lawful purpose, in any media now known or hereinafter invented, without further notice, permission, or compensation. I hereby assign to the Station, its parent, subsidiaries, affiliates, successors and assigns whatever rights or interest I may now or ever have in the Photo/Video/Audio or uses. I understand and accept that the display, publication or duplication of the Photo/Video/Audio may subject me to risk of notoriety, publicity, ridicule, scorn and/or indignity.

By signing this agreement, I, on behalf of myself and the minor child named below, release Station, its parent company Beasley Media Group, Inc., and affiliated companies, and their respective officers, employees, agents and representatives, (collectively, "Released Parties"), from any liability arising out of or in connection with the submission, display, posting, and publication of the Photo/Video/Audio as described above, including (without limitation) any fees or other compensation claimed by any third party purporting to represent me or the minor child named below. I, on behalf of myself and the minor child named below, further release, discharge and agree not to sue or make any claims against, and also agree to indemnify and hold harmless the Released Parties in connection with any and all causes of action or suits or proceedings of any kind, in law or equity, even if caused by the negligence of the Released Parties, that arise out of or relate to my Photo/Video/Audio, or any breach, or alleged breach by me of any affirmation, undertaking, or obligation of mine in this Release, or of the use of the Photo/Video/Audio for any purpose. If I, or any person acting on my behalf, or the minor child's behalf, initiates any action, proceeding or suit which challenges the legality, validity or enforceability of this Release or asserts any claim that I have released, I will reimburse the Released Parties for all damages and reasonable costs and expenses (including, without limitation, attorneys' fees) incurred in connection with any such action, proceeding or suit.

This Release is intended to be a general release and to discharge and release any and all claims and is intended to be as broad and inclusive as permitted by law. The provisions of this Release are severable if any provision is held by a court of competent jurisdiction to be invalid, void or otherwise unenforceable, and the remaining provisions shall remain enforceable to the fullest extent permitted by law. This Release shall be governed by the laws of courts within the state in which the Station is located and I waive all objections to the jurisdiction or venue of such court(s).
