

AUTHORIZATION AND RELEASE

The undersigned individual is the custodial parent or legal guardian of the minor child named below, which child is participating or has participated in the [Station] (“Station”) [Event] (“Event”). In consideration of my child/ward being able to participate in the Event and the resulting publicity s/he will receive, and for other good and valuable consideration, receipt of which is hereby acknowledged, the undersigned hereby authorizes Station to post the Photo/Video/Audio on its website and third party websites and to use the Photo/Video/Audio for related promotional activities undertaken by Station.

The undersigned represents that s/he knows of no reason s/he may not grant the rights granted in this Authorization and Release. Neither the undersigned nor the minor child named below is represented by an agent or other representative.

By signing this agreement, I, on behalf of myself and the minor child named below, release Station, its parent company Beasley Media Group, Inc., and affiliated companies, and their respective officers, employees, agents and representatives, (collectively, “Released Parties”), from any liability arising out of or in connection with the submission, display, posting, and publication of the Photo/Video/Audio as described above, including (without limitation) any fees or other compensation claimed by any third party purporting to represent me or the minor child named below. I, on behalf of myself and the minor child named below, further release, discharge and agree not to sue or make any claims against, and also agree to indemnify and hold harmless the Released Parties in connection with any and all causes of action or suits or proceedings of any kind, in law or equity, even if caused by the negligence of the Released Parties, that arise out of or relate to my Photo/Video/Audio, or any breach, or alleged breach by me of any affirmation, undertaking, or obligation of mine in this Release, or of the use of the Photo/Video/Audio for any purpose. If I, or any person acting on my behalf, or the minor child’s behalf, initiates any action, proceeding or suit which challenges the legality, validity or enforceability of this Release or asserts any claim that I have released, I will reimburse the Released Parties for all damages and reasonable costs and expenses (including, without limitation, attorneys’ fees) incurred in connection with any such action, proceeding or suit.

This Release is intended to be a general release and to discharge and release any and all claims and is not to be construed as an admission of liability on the part of any of the releasees. The provisions of this Release shall be severable in the event that any of its provisions are held by a court of competent jurisdiction to be invalid, void or otherwise unenforceable, and the remaining provisions shall remain enforceable to the fullest extent permitted by law. This Release shall be governed by the laws of the State of \_\_\_\_\_ (without giving effect to the principles of conflicts of law thereof).
